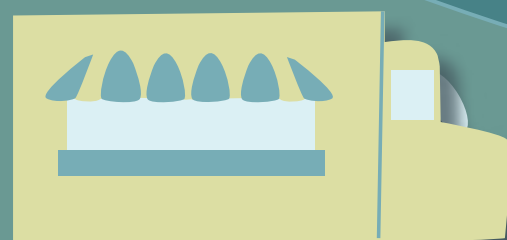

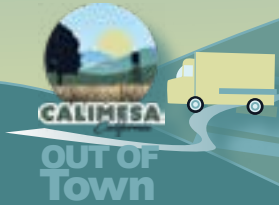

## CERTIFICATE Of Occupancy

**C**ertificate of Occupancy Licenses are required for all businesses that conduct business within areas zoned commercial use. It is required before a business can open their doors to the public and ensures that the building is ready to fulfill its intended use. Such as but not limited to.

- Home Office
- Online Sales
- Contract Work
- Professional Services
- Crafts and Handmade Goods
- Food Production



**H**ome Occupation Licenses are required for all businesses operating at a residential home located in the City of Calimesa. Such as but not limited to:

- Home Office
- Online Sales
- Contract Work
- Professional Services
- Crafts and Handmade Goods
- Food Production



**F**ood Trucks: These mobile kitchens offer a range of culinary delights, from gourmet meals to street food, and can move to different locations to serve customers. Such as but not limited to:

- Coffee and Beverage Trucks
- Taco Trucks
- BBQ Trucks
- Dessert Trucks



**A** sidewalk vending permit and license are required for any person who sells food or merchandise with a pushcart, stand or other non-motorized conveyance. Such as but not limited to:

- Mobile Food Cart
- Mobile Event Services
- Mobile Pet Grooming
- Mobile Retail Store



**V**endor Licenses are required for all Farmers Markets or Street Fairs. To become an event coordinator for a Farmers Market or Street Fair please contact the Planning Department. Once the event has been approved individual vendors may apply for a Vendor License. Vendor Licenses are unique to each event.
